

**SABA® BACK TO SCHOOL 2024 SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION PERIOD:** “The SABA Back to School 2024 Sweepstakes” (“Sweepstakes”) begins at 10:00 A.M. Central Time (“CT”) on 7/1/24 & ends at 11:59 P.M. CT on 8/30/24 (“Promotion Period”).

2. **ELIGIBILITY; AGREEMENT TO OFFICIAL RULES:** Sweepstakes open only to legal and current United States residents who reside in the fifty (50) United States (including the District of Columbia) and are eighteen (18) years of age or older at time of Entry.
